## 'A Voice From the Frontline'

The Government's announcements of changes to Personal Independence Payment and Pathways to Work in the spring statement will lead to the further impoverishment of people who have health conditions and those who are disabled. The cuts, which aim to save £5 billion, will be made at the expense of those who are already facing grave difficulties with the rising prices of utilities and food in the shops on top of the costs associated with their health condition.

The Chancellor, like all Chancellors for the last 30 years pledges that this is all part of a policy to move people closer to the labour market and into a job.

### **BUT WAIT A MINUTE!**

Isn't that what the last government said and the one before that, and the one before that - going back to before the turn of the century?

### **YES, IT IS!**

And each time, the research both independent and that conducted by the DWP shows that the cutting and denial of benefits does not have the effect of enabling work progression to those suffering physical and mental health conditions and those who are disabled.

## WHY IS THIS YOU MAY ASK?



Put simply, all governments over the last 40 years or more, of all political colours, have introduced supply-side policies (in the language of economics). In other words, they focus on the help provided by work coaches, cognitive therapy, job clubs, using sanctions for those not engaging with the job centre's initiatives, as well as the call for people to get off their backsides and out of their sick bed and get a job!

## WHAT'S WRONG WITH THAT YOU ASK!

All the supply-side policies, assume that there is an abundance of employers chomping at the bit to take into employment, people with health conditions and those who are disabled.

## WHERE IS THE EVIDENCE FOR THIS?

There isn't any! For many people with little or no skills or only skills from older industries, it is our experience that there is little or no appetite to employ this cohort. Someone who's CV shows periods out of work with mental health problems will ring alarm bells when reading application forms or when at interviews. How many employees want to take on someone who regularly has to attend hospital or doctor's appointments for their health condition? A simple piece of research will bring this to the attention of a government that wanted to match demand policies with those on the supply side.



## **BUT DON'T HOLD YOUR BREATH!**

One of the only initiatives that recognise the problems of disabled people was the Remploy scheme established in 1949, after the Second World War. Between 2009, and 2014, it found 100,000 jobs for disabled people in supported businesses and allowed public bodies to fulfil their corporate social responsibility objectives purchasing from them. The coalition Government shut the factories! Two years after the closure of the Remploy sites a Parliamentary answer revealed only half the people made redundant had found employment. It is unclear how many were able to sustain their jobs in the medium to long-term. At the same time, DUWC conducted a piece of research following the prospects of people who had been found fit for work, a decision they had challenged but had lost at tribunal and their sickness benefits denied. Out of the 50 people we followed up, only four found work and only two managed to sustain it. The rest were impoverished either surviving on their partners income, using up any savings or making a new claim further down the line.

## **SO THIS IS NOT ABOUT WORK BUT A BENEFIT CUT!**

On the doorstep, in elections, canvassers find a public who think the benefit system is abused. Since the 1980s, the value of unemployment benefits has been massively eroded. From unemployment benefit to Job Seekers Allowance to Universal Credit, the money paid to a person becoming unemployed and presenting themselves as fit for work has been systematically cut by all governments. The Unemployed Workers' Centres have waged many campaigns over the last 40 years on this issue. We have taken the case to Ministers who have looked at us incredulous that they might fly in the face of public opinion and raise the level of unemployment benefit. Over time, the value of these benefits is far lower than those claimed when claiming due to sickness and ill health. No rational person, if viewing their employment prospects as limited or unlikely in the short to medium term would present themselves as fit for work. So this is a massive failure of Government policy over decades – so they shift the blame on to the victims.



Countries that have higher unemployment benefits have far better results in people getting back in to work. If the policy was about getting people into work, the government would substantially increase benefits for those presenting as fit for work, institute Job Guarantee schemes, and work to change the underlying reason for widespread physical and mental health problems in our society. Every Public Health professional will tell you what it is – *poverty and inequality*. Ironically, the government attacks benefits under the guise of saving money, when all should know that the reverse is true. It is short term thinking and is systematic of a political system that is struggling to find answers to long term problems.





# #TAKETHEPOWERBACK

The day of action was to raise the awareness of the private companies pocketing billions of pounds in profit, while members of the public, including a student, OAP, voluntary sector, unemployed and family on low income see nothing but costs of energy going up. From the 1<sup>st</sup> April to 30<sup>th</sup> June the price for energy for a typical household who use electricity and gas and pay by direct debit will go up by 6% to £1,849 per year

The demonstration was to raise awareness and make the call for more people to join Unite Community to fight for a change and get involved with more campaigns.



# Have you received your letter to migrate over to Universal Credit?

You have three months from getting your letter to claim



## 1. Apply on-line

This is the default for Universal Credit – both creating an account, making a claim and then managing the account over the months and years ahead.

Claimants will need:-

- a mobile phone (which can receive text messages)
- an e-mail address
- their bank account details

## 2. Apply by phone 0800 328 5644

Claimants who are unable to go on-line , due to disability can make a telephone claim. They will need:

Details of -housing rental costs

- child dependants
- disabled child dependants
- childcare costs
- Carer's Element
- If already gained, adding Limited Capability for Work & Work Related Activity {LCWRA} status

It is also essential to report any capital and savings over £6000



We will share the details of her funeral when we are made aware




